Oikopolis new apartments complex

The apartment complex is located in Piraeus, approximately 10 km from Athens. The complex is newly built with exceptional design and architecture, and stunning views including the sea.

City of Piraeus:-

The city of Piraeus is located 10 km southwest of Athens (the biggest city in Greece), overlooking the Martoum Sea, which leads to the Saronic Gulf. It is a peninsula surrounded by the sea (although in its geological origin it was an island), and features three natural harbors.

In its creation, Piraeus had served Athens as a port; nowadays it is still the main port of Athens and serves as the industrial center of Greece

Also in Piraeus, is one of Europe's largest container ports (owned by Chinesecompany Cosco Pacific)

The city offers best health and education facilities for Chinese students with a good public transport system and several national recreational parks. An international school was established in 1922 and the University of Piraeus offers many classes in English language.

Oikopolis project profile

Oikopolis is a modern luxurious complex of 316 apartments and 11 shops with exceptional aesthetics and studied functionalism of interior and exterior areas. Apartments vary from 50 m2 to 130 m2 and shops vary from 60 m2 to 450 m2 The construction is of high quality including soundproof double brickwork, Italian granite flooring and wooden flooring in most bedrooms.

General information on residence permits for real estate owner in Greece

Investment requirement:-

A residence permit for real estate owners is a new type of residence permit, for third country citizens who have received a type D Visa for the same purpose. A beneficiary has the right of entry and residence, for a period of five years, if:

 Third country citizens who either own, or intend to own, real estate property in Greece, provided its minimum value is €250.000

Duration of the residence permit for real estate owners:-

• This residence permit is valid for 5 years.

Renewal of residence permits for owners of real estate:-


The residence permit can be renewed. More specifically, the residence permits may be renewed for the same duration and for as many times as the applicant requests. To renew the residence permit, the following conditions must be met:

• The real estate property must remain in the ownership and possession of the applicant.

Absences from the country do not impede the renewal of the residence permit.









Simplified process – residence permit in Greece

Applying for an entry visa type D at Greece embassy in China



Purchase of the property or properties which have a minimum value of €250.000



Collection and submission of the documentation for issuing of the residence permit



Official confirmation from Ministry of Immigration and acknowledgement certificate to allow travel in the EU and Schengen region



Final issuance of the permit

Services	Residence permit in Greece
Price of per square meter (the minimum total purchase must equate Euro 250,000)	1500 Euro per square meter
The taxes payable on the property purchase- 3% of the minimum investment of Euro 250,000	7,500 Euro
2% notary fees on the minimum investment of Euro 250,000	5,000 Euro
1% miscellaneous fee on the minimum investment of Euro 250,000	2,500 Euro

Note: To qualify for the "Golden Visa in Greece", the real estate property's value must be a minimum of Euro 250,000
